



We're Moving!

Due to the new paper machine construction at WestRock in early 2018, we were recently notified that our office must move. After much research, discussion and prayer, your Board of Directors has decided that it is in the long-term best interest of SCI FCU to move into an existing vacant facility at 812 Second Loop Road in Florence. The Board felt that this is the best opportunity for future growth and increased service to our members. While we recognize that this will create a hardship on some of our outlying members, there was no viable solution for SCI FCU to remain on WestRock Property given the option provided to us. There was no scenario that would allow WestRock employees the convenience of walking from the Mill to the credit union. There was also not sufficient time to move our building and continue to provide uninterrupted service to our members. Two years of construction at the Mill would have also created accessibility problems for relocation in the mill area. The Second Loop Road location is an excellent location in Florence, and is on the South side of town, roughly 18 miles from WestRock Paper Mill.

SCI FCU offers many options to conduct business without having to be physically present through safe and secure electronic means, so we are asking all of our members to please continue to support their credit union through this transition. Members can still receive the same level of care from our staff as always. Our new facilities will also offer a drive-through option as well as a secure night deposit for added convenience. Plans are to move our credit union office the first weekend in March. **We will close on Monday, March 12, 2018 while we finalize our move, and open to members at 8:30 am on Tuesday, March 13, 2018. Our new office hours will be from 8:30 am until 5:00 pm, Monday through Friday, with our drive through open from 5:00 pm until 6:00 pm on Fridays.**

We are very excited about this move, and we invite our members to visit us in our new location. Our credit union is member owned and governed by elected volunteers. It is a financial cooperative that was chartered in 1965 by Paper Mill Employees. We believe that SCI FCU is more than a financial institution. It is family! Our goal is to continue to offer excellent personal service to all of you. Your credit union only exists because of member support. We need you. Simply stated; WE LOVE OUR MEMBERS!
