## **INACTIVE ACCOUNT NOTICE**

*What is an Inactive Account?* It's a share (savings) account with a balance under \$250 with no activity for 12 months, including deposits or withdrawals, and no other savings or loan accounts.

*What happens if my account becomes inactive?* A \$2.50 inactive account fee will be charged to your account each month until it becomes active again.

*How can I prevent my account from becoming inactive?* By having activity – we would rather see you use your account than charge you the fee. We'd rather see you take advantage of the savings and loan opportunities at your credit union. We have several options to help you grow your savings through interest-bearing share savings accounts, share certificates and more. We are also one of the best resources you can use to borrow money more affordably.

**77<sup>th</sup> Annual Meeting of the Nebraska State Employees Credit Union**

**Date:** June 11, 2018

Pursuant to Article XVI of the by-laws of the Nebraska State Employees Credit Union, the 2018 elections to fill vacancies in various offices of the credit union will be as follows:

The Nominating Committee has made the following nominations:

**Board of Directors:** Three vacancies for a three-year term each.

Albert Nielsen	Retired from Fremont Fire Department Current Board of Directors Member Credit Union Member for 33 Years
Pete Andersen	Department of Revenue Current Board of Directors Member Credit Union Member for 42 Years
John Shelton	Retired from Nebraska State Patrol Current Board of Directors Member Credit Union Member for 34 Years

**Credit Committee:** Two vacancies for a three-year term each.

Kay Mencl	Game and Parks Commission Current Credit Committee Member Credit Union Member for 22 Years
Thomas Hoffman	Retired from Department of Revenue Current Credit Committee Member Credit Union Member for 40 Years

Any credit union member who meets the membership requirements may have their names placed in nomination by the following method:

Such nominations shall be made by petition not signed by less than 35 members of the credit union. Such members must be members as of January 1, 2018. The petition shall state the name and address of the person being nominated, and include a brief statement of the qualifications and biographical data similar to that listed for other nominees. The petition shall only nominate one person for one vacancy, shall be accompanied by a signed certificate that they are agreeable to the nomination and will serve if elected, and shall be delivered to the Secretary of the credit union no later than May 9, 2018. Such delivery may be accomplished by delivering such addressed to Secretary, Nebraska State Employees Credit Union, 330 S. 16, Lincoln, NE, 68508.

If at the close of business on May 9, 2018, there is more than one person nominated for a position, voting will take place at the credit union main office (330 S. 16, Lincoln, NE) during business hours on June 4 through June 11, 2018. In addition, ballot boxes will be available at the Annual Meeting in Lincoln. The election will not be conducted by ballot box and there will be no nominations from the floor when there is only one nominee for each position to be filled.

If you would like to vote but are unable to come to the credit union office or the Annual Meeting, you may receive an absentee ballot by submitting a written request to the credit union, which must be received by the end of business day, May 15, 2018. Absentee ballots will be mailed on or before June 1, 2018, and must be returned by midnight, June 6, 2018.
