  - Dividend Checking: APR 0.100%, APY 0.100%*
  - Xmas & Vac. Club: APR 0.100%, APY 0.100%*

### VISA DEBIT CARDS

A VISA debit card allows you to make purchases with the money available in your checking account. It will also allow cash withdrawals from your share account at an ATM.

When you visit the Credit Union, apply for a VISA Debit card. Complete the application and a card will be ordered for you. Expect to receive it in the mail within 7-10 days. A separate PIN number will also come in the mail a few days later. You may choose to keep the PIN number assigned to the card, or pick one of your own. Just follow the instructions that come with it.

The VISA Debit card is chip enabled so it will be state of the art safe and secure. This debit card allows you to conduct transactions on the CO-OP, PULSE, STAR and PLUS networks.
